#### Motions:

## Submitted by Mona:

- Change the 30 seconds of silence policy to read:
  - "The secretary has the responsibility to maintain order and ensure a productive business meeting. However, anyone attending the meeting may call for 30 seconds of silence at any time. If that happens, everyone will stop what they are doing and honor the call for silence. Ideally, the time will be used to meditate on our higher power's will for us and to maintain or regain our spiritual centeredness."
  - Rationale of motion
  - Pros:
    - The change of language is less adversarial and will improve the atmosphere at the beginning of the meeting.
    - ABM uses this approach and it's useful.
    - 30 seconds of silence is useful enough to regulate the group
  - o Cons:
    - The text as is sets a tone where people can reflect on the expectations of appropriate behavior for the meeting.
    - Intergroup gets emotional and the 3 person serenity committee is a good plan of action for when things escalate.
    - Creates a safe environment for the unexpected.
  - Vote outcome:
    - 21 votes for
    - 10 votes opposed
    - Motion passes with 21 votes

## Submitted by Matt:

- I move to include the responsibility of updating the service manuall to be part of the Record Keepers position.
  - o Pros:
    - We need someone to update the service manual when motions are passed for service positions.
    - The vague wording gives the person with the commitment autonomy to update the service manual.
    - Digital (not printed) updates means we can update and review when necessary.
  - o Cons:
    - Motion is too vague and does not include necessary information for how this responsibility will be managed by the record keeper service commitment.
    - Not a group conscience.
  - Amended motion by Matt: Move to include the responsibility of updating the service manual, per the motions made at intergroup that are approved, to be part of the record keeper's position.
  - o 30 seconds of silence called by a fellow
  - Amended motion vote outcome:
    - 20 votes for
    - 10 votes opposed
  - Motion made that the vote not reflect the group conscience as it was an uninformed motion.
